Cross-border transport, energy, and digital infrastructure are essential for unlocking trade, mobility, and shared prosperity, yet financing these large-scale, multi-country projects remains a persistent challenge. Despite Africa's strong repayment record, perceptions of high risk and fragmented borrower coordination continue to limit the flow of long-term capital. FINANCING AFRICA'S POWER TRANSMISSION: ACCELERATING CONNECTIVITY THROUGH PPPs AND ASSET RECYCLING Africa's economic transformation depends on the rapid expansion and modernisation of its power transmission networks. While significant investments have gone into power generation, the continent's transmission infrastructure continues to lag, limiting access, regional trade, and the integration of renewable energy. Bridging this gap demands innovative financing approaches that combine Public-Private Partnerships (PPPs) for greenfield projects with asset recycling strategies for existing grids. Transmission infrastructure is increasingly recognized as an investable asset class. By engaging the private sector in developing new lines under PPP frameworks, countries can accelerate delivery and enhance operational efficiency. At the same time, for existing grid networks, asset recycling monetizes operational transmission assets through concession agreements to offer governments a practical means to release capital and reinvest proceeds into new grids expansion for other infrastructure projects. This roundtable will explore how combining these mechanisms can build a sustainable model for building, operating, and reinvesting in Africa's transmission systems, ultimately fostering stronger, interconnected, and financially resilient power networks across the continent.
